PREAMBLE

Mineral Exploration Corporation Limited (MECL) is functioning under Ministry of Mines, Govt. of India with 100% Government of India holding, for systematic exploration of minerals **“To Bridge the Gap Between Initial Discovery of Mineral Prospect and its Eventual Exploitation”**. It is the only organization both in Government and in private sector, possessing entire spectrum of mineral exploration facilities under one roof. Since its inception in 1972, MECL has grown from strength to strength by adopting modern techniques of exploration and it has now emerged as the premiere exploration agency in the Country. The authorized capital is Rs.125 crores.

CORPORATE SET UP

The Company's registered office is at Nagpur, Maharashtra State, India and manages its functions at projects, the main production centers, through a 2 tier system from the Corporate Office at Nagpur. Three Regional Maintenance Centers at Ranchi, Nagpur and Hyderabad are being operated to facilitate the prompt maintenance of plants and machineries deployed at various projects. Technical guidance to the projects, finalization and geological reports, close liaisoning with the clients and looking for new business opportunities in being carried out through the Zonal Offices located at Ranchi, Nagpur and Hyderabad. The commercial activities of the Company are promoted through Business Development Division at Central Head Quarter, Nagpur, in addition two small units located at Delhi and Kolkata are also looking for business opportunities.

OUR OBJECTIVES & WORK RESPONSIBILITIES

1. To plan, promote, organize and implement programme for the exploration of mineral resources land to perform such functions as the Central Government may from time to time, assign to the Company in connection with the exploration of the mineral resources in and outside the country.
2. To carry out geological, geochemical and geophysical surveys for exploration of minerals.
3. To carry out drilling land exploratory mining prospecting operations to prove land estimate the reserves of minerals.
4. To undertake, encourage and promote such other activities as may lead to the establishment of such reserves.

5. To carry out detailed exploration of mineral prospects by geological mapping, related geological studies, geophysical survey, exploratory mining, drilling and services, to carry out exploratory-cum-development mining for Central Govt. or on contract basis for other agencies so that the deposit when handed over to an exploiting agency, may without delay be capable of planned production and to carry out production activities on contract for any agency. The Company may obtain the advice of exploiting agency wherever required.
6. To prepare a feasibility report on a prospect in consultation with an exploiting agency.
7. To undertake contract jobs in various fields of mineral exploration techniques; to take up drilling and mining contracts for purposes other than mineral exploration on payment of scheduled rates.
8. To undertake contracts for mineral exploration outside India either for an Indian Company or a Foreign Company or Government on terms and conditions to be decided by the Central Government on merits of an individual.
9. For the transport land disposal of any quantity of mineral products won during exploration for purposes of scientific work without paying any royalty and for disposal of such production as may be incidental to mining to a Corporation, Government agency or State Government on payment of royalty by the actual user.
10. To offer consultancy services and/or undertake contract jobs in the field of environment studies and management, ground-water surveys, including construction of tube wells.
11. To offer consultancy services and/or undertake job contacts in electronic data processing services including training of personnel.

12. To offer consultancy services for obtaining prospecting licence, mining lease, exploitation by mining and beneficiation for different types of mineral, rocks and ores.
13. To obtain prospecting licence land mining lease for different types of minerals, rocks and ore in its own name in India and elsewhere or jointly with other parties and thereby enjoying the rights of holders of prospecting licence and mining lease as permitted under statutes for the purpose of mining, quarrying, processing, mineral dressing, concentrating, beneficiating, extracting, improving, treating, smelting, refining, preserving, storing, supplying, transporting, selling, distributing, trading, disposing land or doing business either individually and or jointly with other parties or by sub-leasing to other parties or by transferring the lease to other parties.
